

Boston Police Report.

Period of September 26 to present

- October 22- Brush Road and Dana ave- assault with gunshots
- September 15 tire slashed 15 bow street
- O robberies, B and E or larceny or auto thefst, drugreports= 0
- Crime up 22% compared to last year this time. Auto thefts up 103% and Larceny's up 17%; notero residents "lock your cars". Auto thefts on the rise with unlocked cars with valuables
- Anticipating extra patrol for Halloween
- Patrols at the Fairmount Housing on Code 19 work.
- Questions from attendees: Request for Patrols at Martini shell –suspicious activity noted; DCR property dumping and prostitution incidents have gone unnoticed and unaddressed. The only response is to block the parking lot but there is still access for individuals to commit criminal activity. Can there be more collaboration between State and E-18 to address these issues
- Can we invite troopers or have a meeting with the troupers or outreach team to hear the issues and talk with neighbors? Emily will follow-up. Rep Consalvo is exploring earmarking the budget to have a trooper stationed at parks.

PREPARATIONS AND IMPORTANT DATES AHEAD OF THE 2022 STATE ELECTION

Deadline to Register to Vote is Saturday, October 29, to be able to vote in the State Election on Tuesday, November 8! Learn more boston.gov/vote In-Person Early Voting

- Voters registered in Boston can vote during the early voting period starting **Saturday, October 22** and **lasting through Friday, November 4, 2022** at any of the early voting sites. Hours and locations for in-person early voting can be found at boston.gov/early-voting
- Accessible Voting
 - Massachusetts has implemented an Accessible Electronic Voting System. Boston voters may now request, receive, complete, and return their ballot electronically using a secure web portal. More information about voting for persons with disabilities is available at boston.gov/elections. Boston residents may also make requests through the Boston Election Department. The deadline to make a request is **5 p.m. on Tuesday, November 1, 2022**.
- · Vote By Mail
 - Applications for vote-by-mail ballots have been mailed out to every voter in Boston. To be eligible to vote by mail in the State Election, vote-by-mail applications must reach the Boston Election Department by **Tuesday, November 1, at 5:00 p.m.** Vote-by-mail applications can be returned by U.S. mail using the prepaid postcard, in person at the Boston Election Department (located at Boston City Hall, Room 241), or by emailing absenteevoter@boston.gov.

- Ballot Boxes
 - Voters are able to drop their mail-in ballot at any of the **21 ballot drop boxes** the Elections Department has placed around the City, including at both the first and third floor entrances of Boston City Hall. All drop boxes are monitored under 24 hour video surveillance. Drop boxes will also be available at each early voting location during the scheduled voting hours. To find a ballot drop box location, visit boston.gov/elections
- .Voting on Election Day
 - Polling locations for the State Election will be open **from 7:00 a.m. to 8:00 p.m. on Tuesday, November 8, 2022**. Ballots will be available in English, Spanish, Chinese, and Vietnamese. Language assistance will be available on Election Day by interpreters at polling locations or by contacting the Election Department's interpreters phone bank.

MAYOR WU ANNOUNCES EXECUTIVE ORDER TO STREAMLINE APPROVAL OF AFFORDABLE HOUSING

- Mayor Michelle Wu announced that she will sign an executive order designed to speed up the production of affordable housing in the coming days.
- This executive order is a response to the challenges facing Boston's housing market in order to remove barriers and make the process for developing affordable housing easier across the city.
- The current process to approve affordable housing can take as long as 337 days. This executive order aims to reduce that time in half.
- The executive order consists of five components designed to increase the speed by which affordable housing projects are approved for development:
 - Create a more efficient path for Article 80 development review and approval
 - Study and address zoning challenges to affordable housing development
 - Prioritize affordable housing in the development review processes
 - Create a system to track affordable housing reviews and approvals
 - Establish a governance structure to ensure effective implementation

MAYOR WU ANNOUNCES GRASSROOTS FUNDING AWARDS, THE NEW GROWBOSTON ADVISORY BOARD, AND CELEBRATES NEW RAISED BED GARDENS

• Mayor Michelle Wu announced the <u>GrowBoston: Office of Urban Agriculture's</u> Advisory Board that will advise GrowBoston on the equitable expansion of urban agriculture throughout Boston. The Mayor also announced \$600,000 in <u>Grassroots Program</u> funding to support non-profit organizations to develop and renovate urban farms, community gardens, and other open spaces in Boston.

BOSTON PUBLIC HEALTH COMMISSION BPHC URGES CAUTION AS COVID-19 SPIKES IN LOCAL WASTEWATER

The Boston Public Health Commission (BPHC) is urging residents to take proper precautions against COVID-19 amid a significant spike in COVID-19 virus particles in local wastewater that suggests higher levels of community spread.

Boston has not experienced levels this high since May.

COVID-19 vaccines and boosters are free and readily available to the public.

Based on the current trends, BPHC continues to recommend masking indoors to lower the risk of COVID-19.

With flu season on the horizon, taking proper mitigation and prevention measures to avoid severe infection can reduce the strain on our health care system, especially our emergency care infrastructure.

LONG-TERM DEVICE LENDING PROGRAM OFFERS FREE WI-FI ROUTERS AND CHROMEBOOKS TO **BOSTON PUBLIC LIBRARY PATRONS IN BOSTON**

The Boston Public Library is offering over 2,000 home Wi-Fi routers and Chromebooks city-wide through its Long-Term Device Lending Program.

The program is open to any adult resident of the City of Boston who does not otherwise have access to equipment or services sufficient to meet their educational needs.

The program began with 3,000 routers and 3,200 Chromebooks and additional funding has been requested for an additional 3,000 Chromebooks to distribute to residents.
