- Cars parked at the Martini shell at off hours? Complaint noted
- How do we get a plan on the gate shut and open- Doody says it's a challenge to get a plan in place to open and close it. Bender did a survey visual assessment on the car activity in the parking lot. Didn't see any; only did "visual assessment" during daytime hours.
