Announcements:

Rep Consalvo Update:

- Climate Bill passed very important; 3rd major climate bill passed
- \$4billion economic development bill; including Bio and small business community support
- Mayor's Municipal Tax Relief Bill- averted a 28% tax increase for residents; final bill compromise between the 4 largest businesses in the City and include abatement for small business
- Residents can help: Call Senators to urge them to pass the Bill on Monday
- Resident Questions about the Housing Bond Bill and Fairmount Housing: There are resources to help Fairmount on this Bill. Rep. Consalvo will file an additional \$2millon earmark to jumpstart renovations at FHA. The dates and kinds of repairs are unclear. Working with Kenzie Bok and others to make this happen. May take 4-6 months for the details to be sorted out. Senator Augustus toured the Development for more than 4 hours and met with residents. There is interest in prioritizing Fairmount renovations.
- Next WFH meeting invite Sheila Dillon and Kenzie Bok to talk about the plans needed. The development is in need of major repairs. Renovations are intended to make it "safe, warm and dry" and the ideas of making it mixed use to diversify it and re-constitute it is another conversation.

- For Councilor Pepen: may you please discuss if the Slow Streets criteria can be improved to meet the context of our neighborhood to allow a speed hump in Wakefield/Washington and Summit Streets; Eddie will follow up and meet with transportation to address these and report back to us
